Women Empowerment Grievance Redressal Committee

The UGC Regulations (Prevention, Prohibition and Redressal of Sexual Harassment of Women Employees and Students in Higher Educational Institutions), 2015, provide a framework for educational institutions to prevent, prohibit, and redress sexual harassment of women employees and students in the institution.

As per the UGC regulations, it is the duty of all employers to prevent any kind of sexual harassment in the institution and to offer resolution, settlement, and prosecution of any sexual harassment acts. The regulations mandate that all educational institutions must follow the Vishaka Guidelines (JT 1997 (7) SC 384) and take necessary steps as and when required to promote and develop a conducive academic environment and ensure the respect and dignity of all stakeholders.

To comply with the UGC regulations, V.K.R., V.N.B. & A.G.K College of Engineering should establish a Women Empowerment Grievance Redressal Committee (WEGRC) to receive and investigate complaints of sexual harassment from women employees and students. The WEGRC should conduct inquiries and investigations into complaints in a fair and impartial manner, provide redressal and support to the complainant, recommend appropriate action, and maintain confidentiality. The institution should also conduct regular awareness programs, sensitization and training, and report periodically to the management on the number of complaints received, inquiries conducted, and action taken.

By complying with the UGC regulations, V.K.R., V.N.B. & A.G.K College of Engineering can create a safe and conducive academic environment for women employees and students and promote gender equality

The Women Empowerment Grievance Redressal Committee (WEGRC) is a body mandated by the law to address complaints of sexual harassment in educational institutions. The guidelines followed during the establishment of an WEGRC are given below:

1. Composition: The WEGRC should consist of Principal, Senior female staff members from each department and girl students.

2. Appointment: The members of the WEGRC should be appointed by the Head of the Institution or the Principal, as the case may be, based on their knowledge, sensitivity, and experience in dealing with issues related to sexual harassment.
3. Term of office: The term of office of the members of the WEGRC should not exceed three years, and they may be reappointed for another term of three years.
4. Functions: The WEGRC should receive complaints of sexual harassment from women employees or students, conduct inquiries, and recommend appropriate action.
5. Procedure for inquiry: The WEGRC should conduct an inquiry into the complaint in a fair, objective, and time-bound manner. The inquiry should be conducted in accordance with the principles of natural justice, and the complainant and the respondent should be given an opportunity to present their case.
6. Confidentiality: The WEGRC should ensure that the complaint and the identity of the complainant and the respondent are kept confidential.
7. Reporting: The WEGRC should submit a periodic report to the management of the institution on the number of complaints received, inquiries conducted, and action taken.
8. Awareness: The WEGRC should conduct awareness programs on sexual harassment and the rights of women employees and students in the institution.
9. Punitive action: If the WEGRC finds that sexual harassment has taken place, it should recommend appropriate action, which may include disciplinary action, termination of services, or any other action as per the law.

Objectives of Women Empowerment Grievance Redressal Committee

The objectives of a Women Empowerment Grievance Redressal Committee (WEGRC) in an educational institution are as follows:

1. To prevent sexual harassment: The primary objective of the WEGRC is to prevent sexual harassment in the educational institution by creating a safe and conducive working environment for women employees and students.
2. To provide a mechanism for redressal: The WEGRC provides a mechanism for redressal of complaints of sexual harassment by women employees and students in the institution.
3. To ensure confidentiality: The WEGRC ensures that complaints and the identity of the complainant and the respondent are kept confidential to protect their privacy and prevent victimization.

4. To provide a fair and impartial inquiry: The WEGRC conducts inquiries into complaints of sexual harassment in a fair and impartial manner, following the principles of natural justice.
5. To recommend appropriate action: The WEGRC recommends appropriate action based on the inquiry findings, which may include disciplinary action, termination of services, or any other action as per the law.
6. To create awareness: The WEGRC conducts awareness programs on sexual harassment and the rights of women employees and students in the institution to prevent future incidents of sexual harassment.
7. To promote gender equality: The WEGRC promotes gender equality and ensures that women employees and students are not subjected to any form of discrimination or harassment.

Powers of Women Empowerment Grievance Redressal Committee:

The Women Empowerment Grievance Redressal Committee (WEGRC) in educational institutions has the following powers:

1. Receiving complaints: The WEGRC has the power to receive complaints of sexual harassment from women employees and students in the institution.
2. Conducting inquiries: The WEGRC has the power to conduct inquiries into complaints of sexual harassment in a fair and impartial manner, following the principles of natural justice.
3. Conducting investigations: The WEGRC has the power to conduct an investigation into the complaint, if required.
4. Summoning witnesses: The WEGRC has the power to summon witnesses to give evidence in the inquiry or investigation.
5. Examining documents: The WEGRC has the power to examine any documents or records related to the complaint.
6. Recommending action: If the WEGRC finds that sexual harassment has taken place, it recommends appropriate action, which may include disciplinary action, termination of services, or any other action as per the law.
7. Providing redressal: The WEGRC ensures that the complainant is provided with appropriate redressal and support, including counseling or medical assistance, if required.

8. **Maintaining confidentiality:** The WEGRC ensures that complaints and the identity of the complainant and the respondent are kept confidential to protect their privacy and prevent victimization.
9. **Reporting:** The WEGRC is required to submit periodic reports to the management of the institution on the number of complaints received, inquiries conducted, and action taken.

Functions of WEGRC:

The functions of a Women Empowerment Grievance Redressal Committee (WEGRC) in educational institutions are as follows:

1. **Receiving complaints:** The WEGRC is responsible for receiving complaints of sexual harassment from women employees and students in the institution.
2. **Inquiry and investigation:** The WEGRC conduct an inquiry into the complaint of sexual harassment in a fair and impartial manner, ensuring that the principles of natural justice are followed. It also has the power to conduct an investigation into the complaint, if required.
3. **Recommending action:** If the WEGRC finds that sexual harassment has taken place, it recommends appropriate action, which may include disciplinary action, termination of services, or any other action as per the law.
4. **Redressal and support:** The WEGRC ensure that the complainant is provided with appropriate redressal and support, including counseling or medical assistance, if required.
5. **Creating awareness:** The WEGRC conducts awareness programs on sexual harassment and the rights of women employees and students in the institution to prevent future incidents of sexual harassment.
6. **Sensitization and training:** The WEGRC sensitize the members of the institution, including faculty, staff, and students, and educates them on the law and its provisions related to sexual harassment. It also conducts regular training programs for them.
7. **Reporting:** The WEGRC is required to submit periodic reports to the management of the institution on the number of complaints received, inquiries conducted, and action taken.
8. **Confidentiality:** The WEGRC ensures that complaints and the identity of the complainant and the respondent are kept confidential to protect their privacy and prevent victimization.
