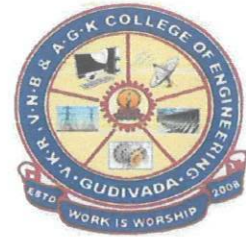

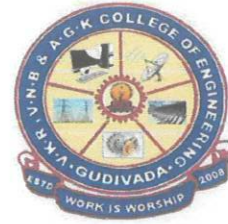
Memorandum of Understanding

Our aim is to provide our students with the opportunity to work with top companies in the industry.

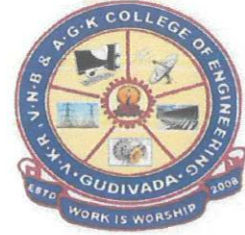
2.0 Recitals

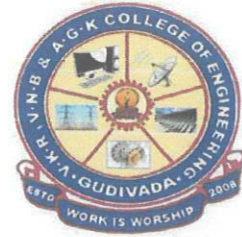
ARTICLE – II: Scope and Terms of Interactions

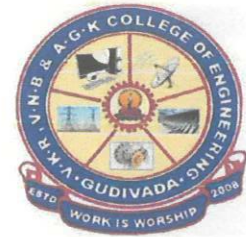
ARTICLE- IV: Consideration / Commercials

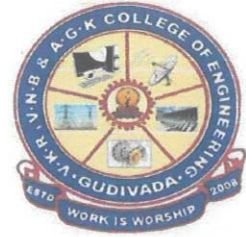
CONFIDENTIAL INFORMATION
