SCOPE:

- The Grievance Redressal committee deals with students Grievances regarding different concerns. It considers issues like involving discrimination or harassment. Concerning issues with campus facilities, Grievances of particular nature of staff Grievances related to academics, unfair evaluation, academic misconduct, or issues with academic advising and whistle blower protection.
- The Grievance Redressal Committee deals with all concerns of workers and students.
- The Grievance Redressal Committee works pertaining to violations of student rights, violations of the college's code of conduct, disciplinary actions, or disputes over access to resources and facilities.
- After accepting any application the Committee will choose and justify the case with respect to scope of enquiring.

PROCEDURE, PERIODICITY AND ATTENDANCE AT MEETINGS:

- The Grievance Committee will meet as and when required. Be that as it may, on the off chance that fundamental, it may meet more as often as possible at the occasion of the Chairman or at the ask of the other individuals to talk about the different issues.
- At slightest three individuals of the Grievance Committee should be shown in assembly.
- If a part of the Grievance Committee is associated with the grievance of the distressed person, the concerned part of the Grievance Committee should not take part within the considerations with respect to that individual's case.
- If the individual happens to be a part of the Grievance Committee, at that point he/she should not take part within the thoughts as a part of the Committee when his/her representation is being considered.

TERMS OF REFERENCE:

- The Grievance Redressal Committee shall consider all grievances submitted in writing by an individual member of the Centre regarding employment/ association, working conditions and any other alleged injustice done to an employee/ student while discharging his/her duties at the Centre.
- The Grievance Redressal Committee shall study the petition/ application and after looking into the relevant documents discuss with those concerned and submit its recommendations and report to the Principal as expeditiously as possible, but in any case within three months of the date of petition/application.
- In case of any difficulties, the Grievance Committee shall have discussion with the Principal before a decision is taken.
- The Grievance Redressal Committee may mediate between the complainant and defendant against whom the complaint has been made, if required
- The Principal, as far as possible, shall be guided by the advice of the Grievance Redressal Committee unless the recommendations of Committee violate basic rules and norms of the Centre.
- Any dead-lock shall be resolved by the Principal.
- The final settlement of any grievance shall be made within a reasonable period (normally not exceeding one month) after the recommendations are submitted to the Principal by the Grievance Redressal Committee.


